## 2006 RAMCA MANAGEMENT CONFERENCE



Members will shortly be receiving information and registration forms for RAMCA's 18<sup>th</sup> Annual Management Conference, to be held April 9<sup>th</sup> – 12<sup>th</sup>, 2006 at The Lodge at Rancho Mirage, in sunny southern California. Speakers include the Mayor and the Director of Public Works of the city of Rancho Mirage, and programs include an open board meeting and an update on the 2006 session of the Virginia General Assembly. Of course, there will be plenty of opportunity to network with fellow RAMCA attendees, and more to do in the surrounding desert cities of Palm Springs, Indio, and Palm Desert than time will permit. One thing is for sure, early registration is a must so watch your mail, quickly review the registration packet, and register early! A sell-out crowd is anticipated.

## 2006 VIRGINIA GENERAL ASSEMBLY CONVENES

Virginia lawmakers are coming back to town on January 11<sup>th</sup> for a 60-day “long session” that looks like it will be dominated by legislative proposals dealing with transportation funding. Sure there will be other issues considered at the session, including adoption of a two-year state budget in the \$70 billion dollar range, but the real battle will be fought over how best to address the state’s pressing transportation-funding crisis.

As every RAMCA member knows, dedicated, long-term and sustainable transportation funding is an essential ingredient for successful construction development in any sector of our economy. The jobs, business growth and quality of life of all RAMCA members and their employees are affected by transportation funding issues. For that reason RAMCA has, and continues to provide, strong legislative advocacy in support of solving this problem.

Outgoing Governor Mark Warner has already proposed \$625 million in one-time transportation funding investments in his proposed 06-07 state budget. While hardly any of this amount is earmarked specifically for central Virginia, it does represent a move in the right direction.

But the solution that RAMCA is seeking must involve long-term funding solutions, not one-time project specific allocations. Fortunately, incoming Governor Tim Kaine acknowledges the crisis, and has already hosted a number of regional forums to hear citizens’ concerns in the area of transportation. A number of RAMCA members, along with RAMCA staff, attended the Richmond forum, which was well attended and generated many useful comments.

The real debate will occur in the halls of the General Assembly as the Senate and House seek the high ground in this highly visible policy issue that will inevitably include taxation discussions. Recent legislative sessions have produced a stalemate as these two bodies deadlocked on the size and scope of a transportation solution. But three things are different this year. First, the financial situation regarding funding needs continues to worsen each year a long-term solution is not achieved. Second, this year the weight of a newly-elected Governor is strongly and publicly behind resolving this core budget issue. And third, Governor Kaine has indicated that if the legislators leave Richmond on their scheduled adjournment date of March 11<sup>th</sup> without adequately addressing this issue, he will call them back into Special Session to specifically do so. (That is what Governor Baliles had to do in 1986 – the last time transportation funding was sufficiently increased in Virginia.)

And there may be secondary VDOT/funding issues considered at the session as well. Legislation to further reduce the size and functionality of VDOT could be considered, perhaps including a personnel cut from the current 9000 to below 5000 employees. Where will a cut that large come from? For starters, there is talk that VDOT should jettison all of its road maintenance functions in favor of the private sector, a position that at first blush RAMCA would support.

RAMCA's financial support of Virginians for Better Transportation (VBT) has also proven to be an effective use of funds. VBT has now run over 3000 radio spots on more than 50 stations statewide, several hundred TV ads on COX Communication stations, and a series of weekly newspaper ads in all the major regional and weekly newspapers in Virginia. As a result of this promotional effort to build grassroots support for adequate transportation funding, the VBT website now has a registered database of 11,500 and the site is averaging 2000 hits each day!

One thing is for sure, transportation funding is going to be the main act at the 2006 session of the Virginia General Assembly. RAMCA, through its financial support of the Virginia Utility and Heavy Contractors Council (VUHCC) which includes our sister associations in northern Virginia and Hampton Roads, will be monitoring the session and lobbying on behalf of our members on a daily basis. Weekly legislative updates can be obtained by going to the *Members Only* section of the RAMCA website. And a final legislative summary of actions taken at the 2006 session will be presented to attendees at the 2006 management conference and to members via this newsletter.
