RAMCA's 43<sup>rd</sup> Annual Installation of Officers' Banquet was held last month at Hermitage Country Club. Outgoing Associate Director Brad Duty (Luck Stone) received a plaque for his service, as did Dave Cosby (Sovereign Paving) who is leaving his post as President to become the Immediate Past President. Dave also received a special gift certificate for the Tide's Inn in appreciation of his leadership during his term as RAMCA President for the last two years.

RAMCA's most prestigious award, the RAMCA Lifetime Achievement Award, was presented to Mr. David A. Ward (Ward & Stancil) for his more than 40 years of service to the industry. ## **GENERAL ASSEMBLY ADJOURNS, TRANSPORTATION PLAN IN TATTERS**

After a brief extension to allow the House and Senate to work out differences in their respective versions of the state's next two-year budget, the 2008 session of the Virginia General Assembly adjourned on March 13<sup>th</sup>. RAMCA, through its membership in the Virginia Utility and Heavy Contractors Council (VUHCC), was represented each and every day of the session and actively lobbied a number of important bills impacting members. A lot got done, but transportation funding didn't! In fact, the resolution of that issue left the session in a lot worse shape than when the session began. A complete RAMCA Legislative Report is enclosed.

### **RAMCA ASKS FOR, AND RECEIVES, MORE TIME TO COMMENT ON PROPOSED SAFETY REGS AFFECTING TRUCKS**

As reported in the last issue of the RAMCA Newsletter, RAMCA recently learned that Virginia OSHA was proposing to exceed federal OSHA requirements by requiring both a back-up alarm and an "observer" when trucks, and a host of other potential vehicles with somewhat obstructed rear views, operate in reverse. Current state and federal safety requirements only require one or the other of these two options.

RAMCA had formally expressed our concern regarding this proposed change in writing to the Virginia Health and Safety Board. Last month RAMCA's Executive Director appeared before the Board to further express our opposition, and to ask for additional time to comment before the state considers final adoption of these regulations.

The Board has now approved our request, and will arrange for a meeting of interested parties in April before reconsidering and voting on final adoption of the proposal. RAMCA staff will be at this meeting and any RAMCA member who would like to participate is urged to contact the RAMCA office. (The RAMCA position is that Virginia does not need to adopt this regulation.) RAMCA will, of course, keep members informed of final action taken on this matter.
