The recession-battered, six-year transportation program calls for spending \$7.7 billion on road, rail and transit work during 2011-16. Of that total, \$5.6 billion will pay for highway projects and \$2.1 billion for rail and public transportation efforts. While the state transportation plan shows an increase over the current \$7.6 billion program, that growth is not expected to match inflation during the six-year period. Even using hundreds of millions of dollars from state highway construction revenues to bolster road repair work, the condition of Virginia's 57,867 miles of state-maintained highways gradually has been deteriorating while the number of vehicles on the roads has grown and demand for transit service has

increased. The six-year program retains full funding for several key highway projects for the Richmond metropolitan region:

- Huguenot Bridge replacement in Richmond and Henrico County;
- Interstate 95 bridge rehabilitations in Richmond;
- U.S. 360 widening in Mechanicsville;
- State Route 10 widening in Chesterfield County;
- U.S. 250 widening in Goochland County;
- Midlothian Turnpike -German School Road drainage improvements in Richmond; and
- I-95's Lewistown Road bridge replacement in Hanover County.

VDOT also recently indicated that the total cost for cleaning up this winter's

three major snowstorms has risen to more than a quarter of a billion dollars. VDOT had budgeted \$79.7 million for this winter's snow removal work. Now the Transportation Department is taking \$183.6 million from this year's maintenance and administration budgets to help cover the snow-related expenditures. The state is applying for up to \$40 million in reimbursements from the Federal Emergency Management Agency. As a result there will not be maintenance occurring that should be occurring. Even using hundreds of millions of dollars from state highway construction revenues to bolster road repair work, the condition of Virginia's highways has been deteriorating gradually, according to a VDOT study.

Despite the many months that have passed since those meetings, a final draft of the ordinance has not yet been adopted.

The County is still testing the applicability of "ball markers" which apparently has held up any final action. In addition, the County has assured RAMCA that we will have an opportunity to review the final draft before it is considered for adoption by the Board of Supervisors. As always, RAMCA will keep members informed of any progress in this area and provide links to the new standards once they are adopted.

## OSHA IS STEPPING UP ITS EFFORTS – BE WARNED

The Obama administration has strong ties to organized labor. So it should be a surprise to no one that OSHA will be stepping up its enforcement efforts in a big way in the coming months. More than 150 new inspectors will be hired this year and the department's budget will be increased 10% with enforcement getting \$25.5 million as opposed to a \$1 million increase for compliance assistance. New standards will be promulgated for confined space, cranes, ergonomics, fall and amputation hazards and dangers associated with excavation and trenching. Much of this new focus centers on work many RAMCA contractors perform. Given that fact, this is probably a very good time to review, and if necessary enhance, your current safety program.

RAMCA has also obtained a copy of a memo from the Assistant Secretary for Occupational Safety and Health to all Regional Administrators. In it, there are a number of important administrative changes being implemented that will affect how OSHA cases are handled, and fines assessed. The memo is attached with this newsletter for your information.

**WHITE LINING BACK ON THE BURNER**

Nearly 20 years ago RAMCA fought the requirement that contractors mark, using white paint the area of proposed excavation when calling in a Miss Utility locate ticket. As a result of our efforts at that time, the present law says white lining may be used if the contractor is unable to provide other ways to effectively communicate the area to excavated.

The State Corporation Commission (SCC) however, is now reviving the issue of white lining in an effort to reduce the number of tickets which do not provide enough information for accurate marks to be put down, resulting in call backs for remarking or marking substantially more area than the excavation encompasses. RAMCA does not believe the scope of these problems requires a change to mandatory white lining, and has begun discussions with various affected parties to share our concerns with this proposed change.

It is expected that the SCC will propose a work group, on which RAMCA will be represented, to attempt to find some common ground on this issue. We will keep our members advised of these discussions and any outcomes which may require us to become both excavators and painters. We hope such an outcome will not be reached.

**NO MATCH RULE ENDS, BUT ICE AUDITS COULD INCREASE**

The U.S. Department of Homeland Security has ended its effort to adopt a controversial “no match” regulation targeting employers that have undocumented workers. First announced some two years ago, the rule required employers to terminate workers when their social security did not match the number on file at the Social Security Administration (SSA). A California judge blocked the rule from taking affect based on inaccuracies in SSA records and that injunction has remained in effect for some two years. Recently the Obama administration decided to abandon the legal fight and rescind the order.

But the Department has announced that it plans, instead, to step up its audits of employers Form I-9, Employment Eligibility Verification as part of the Department’s Immigration Customs and Enforcement (ICE) Agency’s long term strategy to address and deter illegal aliens.
